

model release

The basis for this release is an arrangement where Model agrees that in exchange of modeling time, Model shall receive non-watermarked processed Images delivered to Model and/or Agency by Photographer within 10 business days, which shall be of a resolution of 2400x3000 pixels or larger.

Model agrees that copyright, moral rights, and all other intellectual property rights to the Images belongs to Photographer and/or his or her heirs, licensees or assigns, with full right of lawful disposition in any manner. Model agrees that, while Model may use the Images cropped or otherwise manipulated for purposes related to the promotion of Model's modeling business, including, but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, and that Model may transfer these rights to a representative or agency acting on behalf of Model for commercial modeling purposes, Model will not sell rights to any of the Images without Photographer's prior consent.

Photographer agrees that while Photographer may use the Images for purposes related to the promotion of Photographer's photography business, including, but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, Photographer will not sell or otherwise transfer publication rights to any of the Images except with Model's prior consent. Photographer agrees not to use these Images, or cause these Images to be used, in any manner subjecting Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.

Photographer and Model represent and warrant that Photographer and Model are both at least 18 years of age and have the full legal capacity to execute this release. Model and Photographer agree that this release is irrevocable, worldwide and perpetual, and will be governed by the laws of the state of Colorado, United States of America.
